

# INTERTEK GREEN LEAF TESTED MARK AND LABEL



Note: The above Green colour is the preferred one to be used.





#### A). Rules of Using the Intertek Green Leaf Tested Mark (the Mark)

- The Mark could be used on either the product or the packaging of the product.
- Size of print of the Mark There is no minimum size specified. The Mark could be reduced or enlarged proportionally according to the actual needs but recommend not to be smaller than 13mm (0.5") wide, depending on resolution used, however, it is not allowed to reduce the size to an extent that is unclear or the associated text becomes illegible. On the other hand, the Mark should also not predominate over the name of the manufacturer or company selling the product.
- **Number** as documented in the Certificate of Conformity (CoC) must be quoted to identify the case for the purpose of traceability and shall be put in close proximity to the mark.
- For claim statements, they could be quoted as appropriate. Format of claim statement is as follows:
  - a) PVC Free
  - b) Chemical Name (as relevant to the claim)
  - c) Biodegradability

Font of the claim statement shall be Calibri.

Intertek website (<a href="http://www.intertek.com.cn/cert\_search.html">http://www.intertek.com.cn/cert\_search.html</a>) for checking validity of CoC could be quoted. If quoted, it should be put in close proximity to the number of CoC.

# B). Label

- The Label is an option depending on your preference. If the Label is adopted, then it shall be:
  - a) in the user guide or relevant accompanying documentation if a user guide is not available; or
  - b) on the packaging.
- Color code of the Label:
  - Green, C/87.84 M/7.84 Y/81.18 K/0.78;
  - Light green, C/21.96 M/1.96 Y/20.3 K/0.2
- Content of the Label shall be in the following format.

Claims	Details in Label
PVC free	This product has been independently tested.
	No PVC content is detected.
Chemical tested	This product has been independently tested for items below.
	- Chemical name EEE in accordance with Regulation No. /
	- Chemical name FFF
Biodegradability	This product has been independently tested for biodegradability as below.
	- Product GGG achieves the pass level for ready biodegradability in
	accordance with OECD 301A/301F.; or
	- Product HHH achieves the biodegradability of XX% over XX days in
	accordance with ASTMD5511-18 / ISO15985-14.

Labels of multiple claims, if used, shall show the relevant claim details in full.

Note: The number of the Certificate of Conformity (CoC) is to be added to the Label.

# Intertek Green Leaf Tested Mark on Tested Products and / or Packaging

The Mark shall always appear on the Tested Product (or specified as above) with the number of CoC. The Mark shall not be displayed on products, which have not been tested.

#### **Advertisement, Literature and Sales Materials**

Intertek encourages use of the Mark in advertising and will provide advice to you on the matter of using the Mark for promotion.

If there is only one Intertek Tested Product in the print advertisement, or if all models / products shown or described in the advertisement are tested, you may use the Mark on the advertisement. However if there are some models / products not tested , the Mark must appear as close as possible to the model / product that is tested so as to clearly distinguish a Tested Product from a non-Tested Product. The same applies when using the Mark in your website.

Broadcast advertising must be submitted to Intertek for prior, express and written approval.
